A RESOLUTION REGARDING THE RULING OF THE UNITED STATES DISTRICT COURT IN CASE #2-06-CV-07185-HGB-SS.

WHEREAS, legal review has determined that the ruling of the US District Court in Case# 2-06-CV-07185-HGB-SS is applicable to all case-related matters concerning Ordinance #1179-12-09, and;

WHEREAS, compliance with the Orders and issues raised in the above-referenced case requires the Parish of St. Bernard to act expeditiously, and;

WHEREAS, pursuant to Housing and Urban Development Case No. 00-11-0024-8, HUD has requested the Parish of St. Bernard to appropriately and expeditiously respond to its inquiry.

THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the Governing Authority of St. Bernard Parish, does hereby appoint a Council representative, namely Wayne J. Landry, to work with the Parish Government and HUD to mitigate and/or reconcile all compliance issues with the Order issued by the Court in the above-referenced case.

BE IT FURTHER RESOLVED, If any section, clause, paragraph, provision or portion of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Resolution, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Resolution with the invalid portions omitted.


